Tenders may only be submitted on the tender documentation that has been issued.

The 80/20 preferential procurement system, as stated in the Cape Agulhas Municipal Procurement Policy (2011), will be used when considering tenders. An original and valid Tax Clearance Certificate, as issued by the South African Revenue Service, must be submitted with the tender.
